HISTORY OF FONDUE

By all accounts, the melted-cheese dish of fondue is a Swiss tradition. Most references agree that cheese fondue originated high in the Swiss mountains.

Swiss cow herders melted cheese with wine to create the fondue. They then dipped old bread into the cheese to help moisten the bread.

According to the Chef Talk Glossary, fondue means literally “to melt” in French.

Cheese fondue eventually made its way out of the mountains onto the tables of the Swiss aristocracy. Here Swiss nobles, entertaining dignitaries from neighboring countries, introduced fondue to the world.

Throughout the 1960s and into the 1970s, fondue was the focus of friendly get-togethers across the nation.

One popular Swiss custom associated with fondue goes as follows: If a woman drops her bread into the fondue, she has to kiss all of the men at the table; if a man drops his bread, he has to buy a bottle of wine. If the person drops their bread a second time, he or she must host the next fondue party.

TIMELINE OF THE MELTING POT

1975	The Melting Pot opens its first location in Maitland, Fla. outside of Orlando. The first restaurant has four tables and a limited menu consisting of cheese and beef fondue.
1979	Johnston brothers open The Melting Pot’s first franchise location outside of the Orlando market in Tallahassee, Fla. Current sustained operations: 3
1985	Johnston brothers purchase all rights to the restaurant chain and establish The Melting Pot Restaurants Inc. (TMPRI). Current sustained operations: 9
1985-1995	These years are marked by conservative, steady growth by opening two to three franchised restaurants per year. By 1995, 26 restaurants are open.
1995-2001	The Melting Pot opens 20 restaurants (averaging 3 to 5 per year).
2005	The Melting Pot turns 30 and celebrates its 100th location.
2010	The Melting Pot open’s it’s first international location.

Each Melting Pot Restaurant is locally owned and operated.
