Large Room (seats up to 32 and only available Monday - Thursday or during the day) - \$1500) will be applied. Minimums can be met with food, beverage, and/or merchandise. Any unmet minimum will be charged as a "Room Fee." Large parties are booked for two to four hours, depending on the size of the party. As a courtesy to other guests booked after your reservation please ask your guests to arrive on time and allow for travel and traffic conditions. A deposit of \$25 per guest will be charged to your credit card if your party fails to call and cancel the reservation by 5 p.m. three days prior to the event. A reservation will not be held for your party until contract is returned. Although we can apply separate payment denominations to the total check, we are unable to provide separate itemized checks.
