If no final head count is given three days prior, the party will be billed for the number of guests provided on the Large Party Agreement. The restaurant will only block space for the agreed upon number of guests. The restaurant reserves the right to use any tables around the party unless other arrangements are made through the event coordinator and written in the final agreement above and room minimums (Small Room (seats 12) - \$750 minimum. Large Room (seats up to 32 and only available Monday – Thursday or during the day) - \$1500) will be applied. Minimums can be met with food, beverage, and/or merchandise. Any unmet minimum will be charged as a "Room Fee." Large parties are booked for two to four hours, depending on the size of the party. As a courtesy to other guests booked after your reservation please ask your guests to arrive on time and allow for travel and traffic conditions. A deposit of \$25 per guest will be charged to your credit card if your party fails to call and cancel the reservation by 5 p.m. three days prior to the event. A reservation will not be held for your party until contract is returned. Although we can apply separate payment denominations to the total check, we are unable to provide separate itemized checks.
