A fee of \$20 per guest will be charged to your credit card if your party fails to call and cancel the reservation by 5 p.m. two days prior to the event and if more than half of your party fails to show up for your event without two days notice. A reservation will not be held for your party until contract is returned. Although we can apply several payment denominations to the total check, we ask that no more than 3 payments be used.
