A charge of \$10 per guest will be charged to your credit card if your party fails to call and cancel the reservation by 5 p.m. three days prior to the event. A reservation will not be held for your party until contract is returned. Although we can apply separate payment denominations to the total check, we are unable to provide separate itemized checks.
