WE DO NOT OFFER PRIVATE DINING. All prices are food packages only. Beverages, tax and 20% gratuity are not included in the package price and will be added to the final bill. If no final head count is given three days prior, the party will be billed for the number of guests provided on the Large Party Agreement. The restaurant will only block space for the agreed upon number of guests. The restaurant reserves the right to use any tables around the party unless other arrangements are made through the event coordinator and written in the final agreement above. Large parties are booked for three hours, depending on the size of the party. As a courtesy to other guests booked after your reservation please ask your guests to arrive on time and allow for travel and traffic conditions. The Melting Pot has the right to hold the reservation for a total of 15 minutes after the reserved time. The whole party (final head count) MUST be present upon being seated. The Melting Pot has the right to cancel said reservation if the party does not arrive at the reservation time, or said 15 minutes grace period. A deposit of \$50 per guest will be charged to your credit card if your party fails to call and cancel the reservation by 5 p.m. three days prior to the event. A reservation will not be held for your party until contract is returned. Although we can apply separate payment denominations to the total check, we are unable to provide separate itemized checks. Credit Card information may be communicated over the phone if desired. The Melting Pot of Atlanta will only use your personal information and credit card information for this specific agreement and all gathered personal information and credit card information for this large party event will be destroyed immediately after use.
