The party assumes responsibility for the conduct of all persons in attendance at the event. This is to include but not limited to any cost incurred by the restaurant for damages by or resulting from conduct of persons in attendance at the event and unpaid tabs opened by guests. Large parties are booked for a leisurely two and a half hours. As a courtesy to other guests booked after your reservation, please ask your guests to arrive on time and allow for travel and traffic conditions. Although we can apply separate payment denominations to the total check, we are unable to provide separate checks. Cheese and, or chocolate parties are not available on Fridays and Saturdays or during holidays or other promotional events.
